<u>Safeguard Yourself:</u> Unsolicited peddlers going door to door in Leisure Town is nothing new but it is ramping up as the weather improves. Lately, this seems to focus on solar and utility rates and retirement communities can be easy prey.

Before any solicitor can operate in Vacaville, they must apply for a license, pay fees, be fingerprinted, photographed and have a background check. They must always carry their license on them and show proof when asked (VV City Code Chapter 9.18).

If someone comes to your door and says they are working on behalf of PG&E, ask to see their identification. All PG&E employees are always willing to show that. Call the PG&E Customer Service line if you feel uneasy 1-800-743-5000.

Clean Up Day: Shake off those dreary winter doldrums and purge your clutter. Use our Spring Cleanup Event on May 20th to clean out your closets, garages and backyards. Debris bins will be available for you to drop off accepted items. Volunteers will pick up for those unable to haul. 

#### **Preventing Catalytic Converter Theft**

Leisure Town has recently experienced a few incidents of catalytic converter thefts. According to Carfax, the top 10 targeted vehicles are Toyota Prius, Honda Accord, Honda CR-V, Toyota Tacoma, Ford F Series Truck, Subaru Forester, Toyota Camry, Ford Econoline, Ford Explorer, and Nissan NV. Read on for a few tips that may help reduce the chance of being a victim.

- Shield guard kits are available online
- Catalytic converter Alarms are available online
- Etch your license plate number onto your converter, allowing it to be identifiable to law enforcement.
- Park in well-lit areas
- -Spray your converter with bright paint to deter buyers
- -Park your vehicle in the garage
- -install sensor lights and cameras around your vehicle

#### PG&E: Learn about discount programs

CARE and FERA are PG&E discount programs that help eligible customers pay their energy bills. Over 1.4 million customers are receiving a bill discount through these two programs. Simply complete the online CARE/FERA enrollment form and we'll let you know if you're eligible.



**California Alternate Rates for Energy Program (CARE).** A monthly discount of 20% or more on gas and electricity. Participants qualify through income guidelines or if enrolled in certain public assistance programs.

**Family Electric Rate Assistance Program (FERA)**. A monthly discount of 18% on electricity only. Must be a household with three or more people. Participants qualify through income guidelines.

### City of Vacaville Water Assistance: Low or Fixed Income Discount Program

Low Income Discount: Customers on a fixed or lower income may qualify for a discount on their water service charges. In order to qualify, customers must meet income requirements and be enrolled in the PG&E California Alternate Rates for Energy (CARE) program.
